There was a discussion about the size of artwork accepted. We originally stated all artwork must be 12X12 including the frame. Because of the challenge of getting frames that the finished size is 12X12, we have amended the size requirements to the following:

- If your work is NOT FRAMED, the size of your artwork must be 12x12
- If your work is FRAMED, your frame should be 1" or narrower. The finished sized of your artwork should still be 12x12.
