## **New Business**

Approval to provide \$2000 for SE Chapter 1<sup>st</sup> Place Award for Bienniel. Motion was made by Kristine Henricks, Seconded by Mark Weller, passed Unanimously. (Vote was to provide proof for Bookkeeper so she can move the funds.)

Current MOWA show highly recommended, as it the new St. Kates show. The members show will be up soon.

Odd Month Challenge for November is An Artistic Representation of You. Each member can submit up to 5 entries. Entry deadline to our FB page album is 1159 on 31 OCT 23 . Add you photos to the FB page album and vote for others: Like = 1PT, Other Emoji = 2 PTS, Comments = 3PTS (doesn't count if you like, emoji or comment on your own posts). Discussion about Odd Month Challenge. Do we need to revise it. Same artists are participating each month. Do away with winners? More inviting to participate. Is it overwhelming? This should always be a fun event. Should we do a random drawing to pick a winner, by Committee: choosing 3 fun pieces, 2 deeper and 1 conceptual? Steven demonstrated how to add photos to albums on our FB page.

Ronald McDonald House (RMDH)-Current works were hung in SEP and come down in DEC 9 for the next round. 5 artists have submitted 13 pieces. We need 12 more. Previous round entrants will be allowed after 6 OCT 23. Size range is 12 x 12 to 36 x 36. These works should evoke happy/hopeful feelings. RMDH has final say about what hangs. 2<sup>nd</sup> round ends approx. 9 MAR 24. Have a look at the current

works and dates on the WVA website. RMDH CEO said he hadn't realized how blank and bleak the walls were until he saw them hung with art.

Steven walked us through the Formstack Application for the Modern Landscape show. If we have 40+ entrants, we will use the 40 1<sup>st</sup> choice pieces. If there are less than 40 entrants, a random drawing for 2<sup>nd</sup> choice works will be held to get the piece count to 50. Applications open 16 OCT 23 at 9am. There is a \$15 fee using PayPal. The prospectus is on the WVA website.

Go Figure, Juried Show at the Plymouth Art Center, juried by Mary Tilton and Jayne Jackson (current and prior Chapter Chairs of the SC Chapter) will be the jurors. Applications will begin on 10/16 at 9am. Entries are \$30 for up to 2 pieces. Please remember the venue has the final say on all art chosen, no nudes. The prospectus is available on the WVA website.

Steven would like the membership to consider initiating some social events in the next year: A picnic, seeing a show together? What do you think?

In May, Steven will have been our elected Chairperson for 2 years, in addition the the 18 months he served before that as an interim Chairperson. He can serve one more elected term, however, he's feeling worn out and needs some help.
