

## WVA – Southeast Chapter Meeting Minutes November 1, 2023

Amendments to the WVA Constitution and Bylaws: There were 130 votes cast, all Yes votes. The amendments and bylaw changes have been approved.

Biennial results will be posted on the WVA website on Monday, 6 NOV 23.

Budget: Steven shared his screen with the latest budget data. Steven and Patti will meet to discuss/update numbers and provide that information to the Chapter for a vote.

Odd Month Challenge for November is An Artistic Representation of You. Each member can submit up to 5 entries. Entry deadline to our FB page album is 1159 on 31 OCT 23 . Add your photos to the FB page album and vote for others: Like = 1PT, Other Emoji = 2 PTS, Comments = 3PTS (doesn't count if you like, emoji or comment on your own posts). Steven demonstrated how to add photos to albums on our FB page. There was some discussion about making the Odd Month Challenge just for fun, with no winner declared or by random drawing.

Ronald McDonald House (RMDH)-Current works were hung in SEP and come down on DEC 9 for the next round. 18 pieces have been submitted. We need 7 more. Size range is 12 x 12 to 36 x 36. These works should evoke happy/hopeful feelings. RMDH has final say about what hangs. 2<sup>nd</sup> round ends approx. 9 MAR 24. Have a look at the current works and dates on the WVA website. RMDH CEO said he hadn't realized how blank and bleak the walls were until he saw them hung with art.

Modern Landscape has 16 applications, our goal is 40-50 pieces. These pieces should be new or not shown previously in a WVA show.

Go Figure, Juried Show at the Plymouth Art Center, by Mary Tilton and Jayne Jackson (current and prior Chapter Chairs of the SC Chapter) will be the jurors. 12 pieces have been submitted, applications close 8 DEC 23.
